

## Overdraft Protection Opt In Consent Form

On July 1, 2010, new federal regulations regarding Overdraft Protection (ODP) will become effective. Without action on your part this regulation will discontinue some of your Overdraft Protection (ODP) privileges. Please read the following carefully.

### What You Need to Know about Overdrafts and Overdraft Fees

An overdraft occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway.

Currently, we do authorize and pay overdrafts for the following types of transactions:

-Checks you have written                      -Withdrawals you have authorized

\*We **do not** authorize and pay overdrafts for the following types of transactions unless you ask us to (see below):

-ATM Transactions                      -One-time Point-of-Sale (POS) Debit/Checking Card Transactions

We pay overdrafts at our discretion, which means we do not guarantee that we will always authorize and pay any type of overdraft. If we do not authorize and pay an overdraft, your transaction will be declined.

### What fees will I be charged if Linkage Credit Union pays my overdraft?

- We will charge you a fee of up to \$25 for each item paid by overdraft.
- There is no limit to the total number of times we can charge you for overdrawing your account.

### What if I want Linkage Credit Union to authorize and pay overdrafts on my one-time Point-of-Sale Debit/Checking and ATM card transactions?
